In continuation of our earlier Notification No.166/WBBPE/D.El.Ed./2023 Dated: 01/08/2023, regarding the D.El.Ed. Part-I Examination for the session 2021-2023, the following modalities for holding the D El Ed Part - I (Theoretical) Examination (Regular) of the Session-2021-2023 are hereby notified:

- Seating arrangement shall be made in such a way so that a considerable distance is maintained from one another.
- There shall be a provision for sick room, attached to each venue for the examinees suffering, or if they feel any sort of illness like fever/cough/cold etc.
- No guardian/ parent/ outsider shall be allowed near the gate or anywhere around within 100 yards of the venue.
- The same procedures as above will be strictly pursued on all the five days of aforementioned examinations.

- Physically handicapped/ specially abled or otherwise incapacitated (duly certified by the competent medical authorities of the Government of West Bengal) examinees will be allowed to use 'scribes' (writers) as per our instructions/ guidelines under **Memo No.193(24)/WBBPE/D.El.Ed./2023 dated 24/08/2023.**
- Compensatory (Additional) Time will be allowed to the candidates in terms of the guidelines in paragraph-XII of the office memorandum, F.No. 34-02/2015-DD-III Dated-29/08/2018 of the Ministry of Social Justice and Empowerment, Department of Empowerment of Persons with Disabilities, Govt. of India.
- The said notification is attached to this notification and is available in the aforementioned websites for ready reference.
- Instructions to the Venue-in-Charge or Venue-Superintendent/Officer-in-Charge of the Venue should be abided by strictly without any deviation. In case of any deviation, the matter should be brought under notice of the concerned district authority who will take up the matter with the Board for negotiation and final verdict.
- Candidates will not be allowed in the examination hall along with prohibited/banned items like books, written notes and electronic gadgets like mobile phones, scientific calculators, pagers, digital diary or any type of scribbling material during the examination period. If anybody is found to have with them any such items, she/he will be expelled from the entire period of examination.
- The candidates should abide by the rules strictly, mentioned on the reverse side of their Admit Cards in each day's examination.
- The candidate is required to produce the Original Admit Card issued to them for the said examination and valid Identity Card (Voter's Id/AADHAR Card/PAN Card/Passport/MP Admit Card) issued by the competent Govt. authority to avoid impersonation for admission in the examination hall. A candidate without possession of the aforesaid documents shall under no circumstances be permitted to appear at the said examination by the Centre-in-Charge.
- Each candidate has been allocated a seat indicating his/her Registration Number and Roll - Number. Candidates should find and occupy only the seat assigned to them. If any candidate is found to have changed his/her room or the seat on his/her own, other than allotted, his/her candidature shall be cancelled immediately and no plea would be entertained thereafter.
- Any candidate arriving at the venue allotted to him/her after the commencement of the examination, shall not be permitted in any way to appear for the examination.
- Smoking, chewing gutkha, spitting or creating any such nuisances in the examination hall/room is strictly prohibited. No food items, or beverages like tea, coffee, cold drinks are allowed inside the examination room or may be consumed during the

examination.

- No invigilator will be allowed to carry phones into the examination halls. She/he has to submit phones to the Centre Superintendent/Venue-in-charge latest by 11.15 A.M.
- Only the Centre Superintendent/Venue-in-Charge, Officer-in-Charge and Observers will be allowed to keep phones with them.


