It is further to notify that scanned copies of the Mark Sheets of the said D. El. Ed. Part-I Examination, session 2020-2022, prepared digitally, will also be available on and from 29<sup>th</sup> September, 2022 to 30<sup>th</sup> September, 2022 in the log-in of the respective Institutes for handing over to the bona fide students of the concerned institutes in order to enable them to submit a copy of the same with the application for PPR (Post Publication Review) / PPS (Post Publication Scrutiny) within the stipulated time, preferably by within 15<sup>th</sup> October, 2022.

The date/s of issuance of the Mark Sheets (Hard Copy) of the said D. El. Ed. Part-I Examination will be notified shortly.

- (a) The prescribed PPS/PPR forms will be available with the respective heads of the concerned institution
- (b) The filled in PPS/PPR applications can be sent via e-mail of the concerned D El Ed Institute along with the scanned copy of the online transaction details regarding the payment of fees as prescribed
- (c) Those who want to submit their filled-in-applications (PPS/PPR) physically, shall have to enclose a Bank Draft, drawn on a nationalised bank in favour of "WEST BENGAL BOARD OF PRIMARY EDUCATION", payable at Kolkata, for payment of prescribed fees.
- (d) Necessary Bank details for online transfer of the prescribed fees will be available in the application form for PPS/PPR.

Such NC/Failed candidates, if they come out cleared after PPS/PPR (as the case may be) shall be able to apply online for the Part-II-Examination to be held on and from 28<sup>th</sup> November, 2022 to 30<sup>th</sup> November, 2022, as per our Notification, No. 232/BPE/D El Ed/2022, dated 23/09/2022. The students who have failed or who remain 'NC' are requested to contact with the heads of the concerned Institution immediately for necessary procedures.
