## **NOTIFICATION**

In continuation of our earlier Notification No. 10/BPE/D.El.Ed./2021, dated 25/01/2022, relating to the submission of filled-in-forms online for appearing at the Part-II (Second Year) D. El. Ed (Regular/ Face to Face) Examination (Theoretical)-2019-2021 including that for the continuing/supplementary candidates of sessions 2017-2019/2018-2020, this is to notify for all concerned that the President, West Bengal Board of Primary Education has been pleased to allow all the candidates, who have 'Failed' or remain 'NC' in their Part-I-result, published on 29/12/2021 under Notification No. 274/BPE/D.El.Ed./2021, even after PPS and PPR, to appear at the D El Ed-Part-II-Examination to be held on and from 17.02.2022 all over West Bengal in view of the prevailing pandemic situation, wrought by COVID-19, under the following conditions:

- i. This grant of permission /allowance is **strictly for this year** and cannot be referred to as a precedent,
- ii. The Part-II-result of such candidates, thus allowed, shall be kept "withheld" till they clear in an appropriate manner their Part-I-Examination, to be held and conducted by this Board under subsequent notifications in due course,
- iii. The students who have failed in internal assessment, shall be treated as 'failed' in external part/s also, whatever be the award there. Such candidates shall be required to appear at both the internal and external examinations and pass in each area as per the norms of the Board. The concerned D El Ed institute will have to put such candidates again in the process of 'internal evaluation' and submit marks after completion of fresh internal evaluation.

Now, therefore, all such 'Failed' & 'NC' candidates are directed to visit any of the two websites:
